## Executive Summary

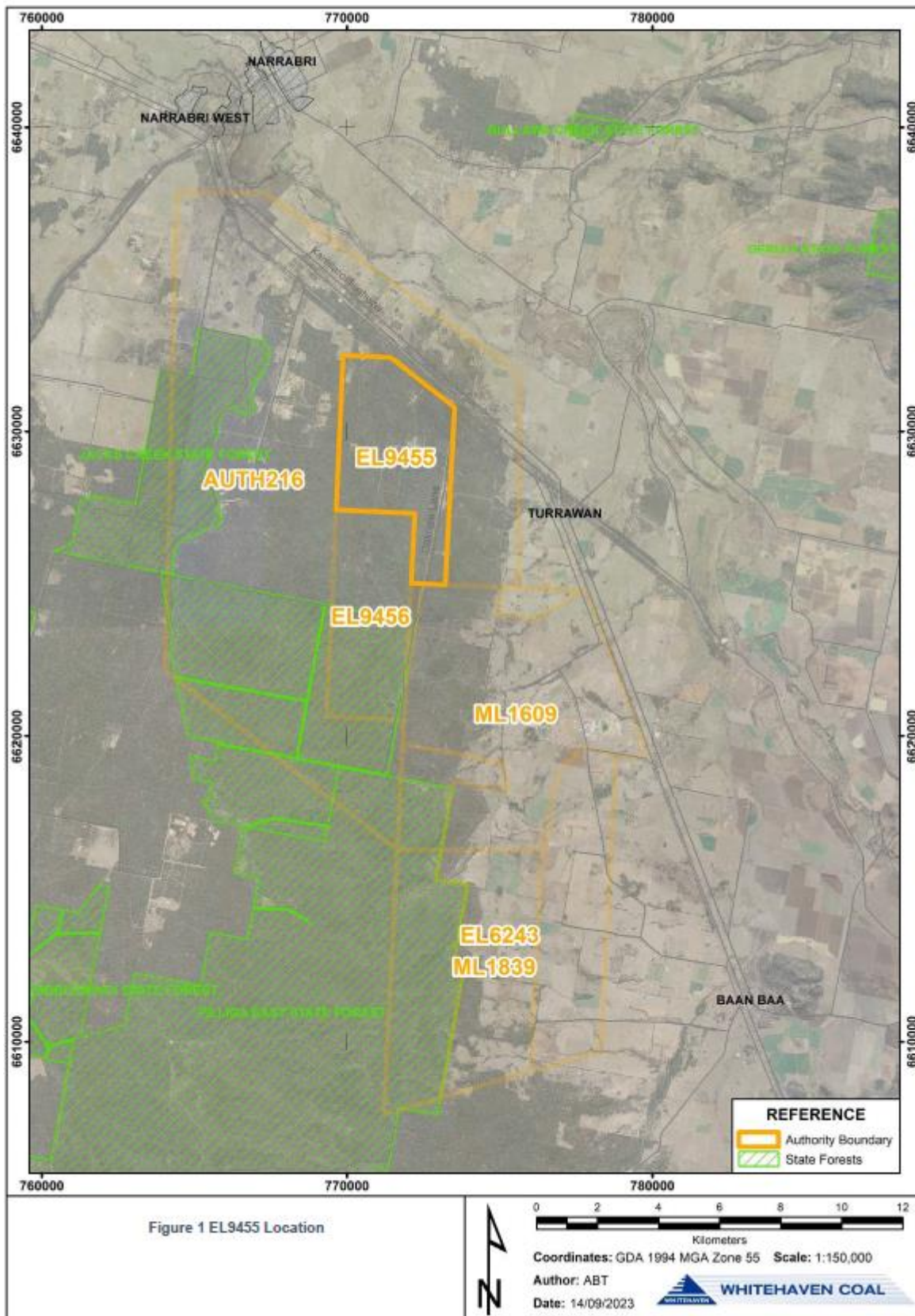


Figure 1: EL 9455 regional location map.

EL9455 is located approximately 12 km south-southeast of Narrabri in the North West Slopes region of NSW (Figure 1). The authority is southwest of the Kamilaroi Highway and is traversed north-south close to the eastern boundary by Oakdale Lane. The current area of the authority is approximately 1,975 ha.

There were no exploration activities undertaken in EL9455 during the reporting period.

There were no community complaints over the past year specifically related to exploration or other activities in EL9455.

## 1. LOCATION AND ACCESS

EL9455 is located approximately 12 km south-southeast of Narrabri in the North West Slopes region of NSW (Figure 1). The authority is southwest of the Kamilaroi Highway and is traversed north-south close to the eastern boundary by Oakdale Lane.

## 2. TITLE, LAND OWNERSHIP, COMMUNITY GROUPS & GOVERNMENT

EL9455 was originally granted on 06 September 2022. The exploration licence is held by a joint venture comprising:

The company Narrabri Coal Operations Pty Ltd (NCOPL) operate the Narrabri Mine and activities within EL9455 on behalf of the Narrabri Joint Venture.

The tenement is in the Narrabri Local Government Area (LGA) and the North West Local Land Services (LLS) area. The Registered Aboriginal Parties (RAP's) are the Gomerai Narrabri Aboriginal Corporation (GNAC) and the Narrabri Local Aboriginal Land Council (NLALC).

### 3. CONSULTATION COMPLETED DURING THE REPORTING PERIOD

No exploration drilling was undertaken within the EL boundary during the reporting period. Survey work related to exploration was undertaken during the reporting period.

NCOPL engages with local residents and the broader community in a number of ways:

- A Community Consultative Committee (CCC) which meets quarterly, comprising of an independent chairperson, local community representatives and a representative from the Narrabri Shire Council;
- The Whitehaven Coal Limited website <http://www.whitehavencoal.com.au> has links to CCC minutes, the complaints register, newsletters and factsheets as well as environmental monitoring, reporting and approvals documentation; and
- Personal contact through community liaison and exploration personnel.

#### 3.1 Community Consultative Committee

The Narrabri Mine CCC is updated on exploration activities within EL9455 at quarterly meetings when relevant. Table 1 provides a summary of items relevant to EL9455 that were discussed during Narrabri Mine CCC meetings during the reporting period; meeting minutes are available on the Whitehaven Coal website.

### 3.2 Engagement with Landowners

During 2023 land access agreements were executed with several landholders, in order to gain access for environmental surveys necessary to prepare the review of environmental factors, required to support the Application for Prospecting Operations form.

January 2024 several landholders were mailed draft Land Access Agreements to allow access for proposed exploration activities under APO0001644 (EL9456) and APO0001655 (EL9455).

May 2024 contacted landholders to advise that exploration activity had been postponed due to site budget constraints, and that land access was no longer required.

### 3.2 Engagement with Government Agencies

Application/s for Prospecting Operations APO0001645 was prepared and submitted to the Resources Regulator on 20 December 2023.

Prior to APO0001645 being approved by the Resources Regulator, due to reduction in exploration expenditure in the site budget it was necessary to delay the exploration program, subsequently NCOPL submitted a request to withdraw APO0001645.

Resources Regulator processed the request to withdraw APO0001645 effective 28 February 2024

## 4. OUTCOMES OF CONSULTATION AND ACTIONS TAKEN

There were no outcomes of consultation requiring action.

## 5. PROPOSED CONSULTATION IN THE FUTURE

NCOPL is committed to continuing the process of community engagement and consultation in the following ways:

- Matters relating to the exploration licence will be notified to the CCC;
- Regular discussions with key local and State government agencies regarding proposed NCOPL exploration activities; and
- Continued implementation of the *Exploration code of practice: Community consultation (2023)*.

## 6. ENQUIRIES AND COMPLAINTS RECEIVED DURING THE REPORTING PERIOD

A register of feedback and complaints for exploration activities at Narrabri Mine is maintained by the Environmental Superintendent, as well as a record of community engagement. These records are available for inspection by the Department. There were no community complaints over the past year specifically related to exploration in EL9455.
