The Offset Management Plan must include, at a minimum, the following information: a. a textual description and map to clearly define the location and boundaries of the Whitehaven Regional Biodiversity Offset Site. This must be accompanied with the offset attributes and a shapefile. b. details of management actions to protect and enhance the extent and condition of habitat values of the offset site, including, but not limited to rehabilitation, weed control, fire management, erosion and sediment control, management of livestock and any restrictions on access of no less than: i. 231.4 hectares of habitat for the Regent Honeyeater and Swift Parrot; and ii. 153 hectares White Box-Yellow Box-Blakely's Red Gum Grassy Woodland and Derived Native Grassland Ecological Community; c. the timing, responsibilities and performance criteria for management actions; d. a monitoring plan including the undertaking of ecological surveys by a qualified ecologist, to assess the success of the management actions measured against identified milestones and objectives; 	Yes	Biodiversity Offset Management Plan (BOMP) was submitted on 20 th December 2012, with comments received on 23 rd July 2013.
