The person taking the action must register a legally binding conservation covenant over the Whitehaven Regional Biodiversity Offset Site ("Yarrari" and "Belah") identified in the map at Appendix 1. The mechanism/s must provide enduring protection of the offset site and be registered within 2 years of the date of this approval.
