Final BOMP was submitted on 20th September 2013 and subsequently approved on 23rd December 2013.</p> <p>All applicable information associated with this condition is included within the plan. A shapefile stored on CD was provided with the plan.</p> <p>A draft WHC Biodiversity Offset Management Plan was submitted to Commonwealth Department of Climate Change, the Environment, Energy and Water (DCCEEW) on 10th March 2023. Following feedback from the former NSW Department of Planning and Environment in September 2023; a revised Offset Management Plan for only the Yarrari & Belah Offsets is currently in preparation and will be resubmitted to Commonwealth DCCEEW in April 2024.</p>
