Re Axe Grinding Groove Rocks located at Whitehaven Mine Site Werris Creek NSW

The Nungaroo Land Council and the Liverpool Plains Shire Council Aboriginal Advisory Committee would like to request that *Axe Grinding Groove Rocks* currently located at the Werris Creek Whitehaven Mine site be relocated to the Willow Tree Visitor Information Centre for public display. The rocks will become an integral part of the tourist attraction *The Kamilaroi: A Highway and a People* project.

The Willow Tree Visitor Information Centre is located at the junction of the New England and Kamilaroi Highways. A recent Aboriginal scoping study identified the need for a prominent marker defining the only highway in NSW named after an Aboriginal nation.

These rocks are of significant cultural importance to the Aboriginal people in this area and at their present position are virtually inaccessible to the general public. Members of both Nungaroo and the Advisory Committee were hoping that this request could be approved and the rocks relocated in time for NAIDOC Week Celebrations in July as a Flag Raising Ceremony to be conducted at the Visitor Information Centre is being organised.
