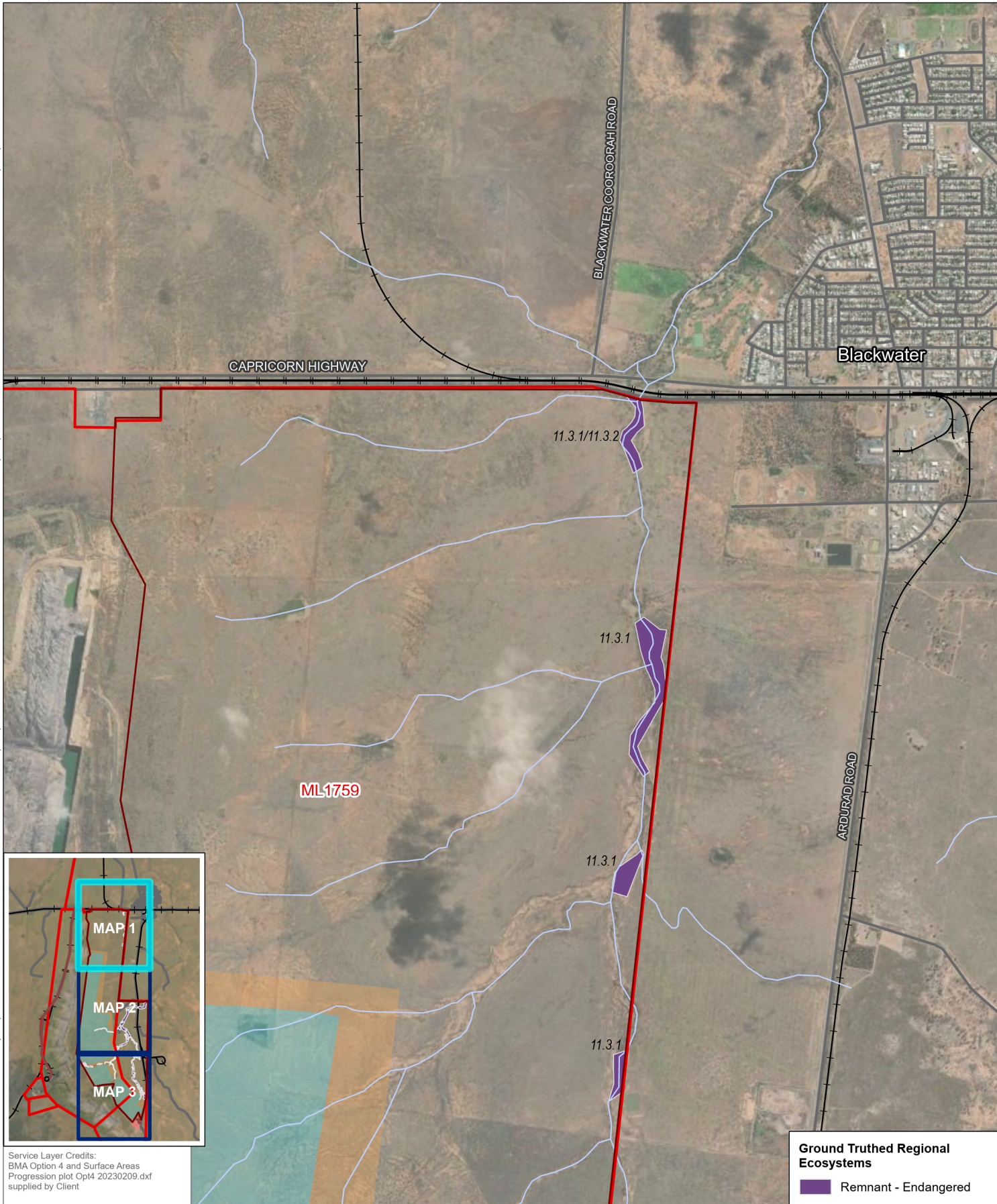

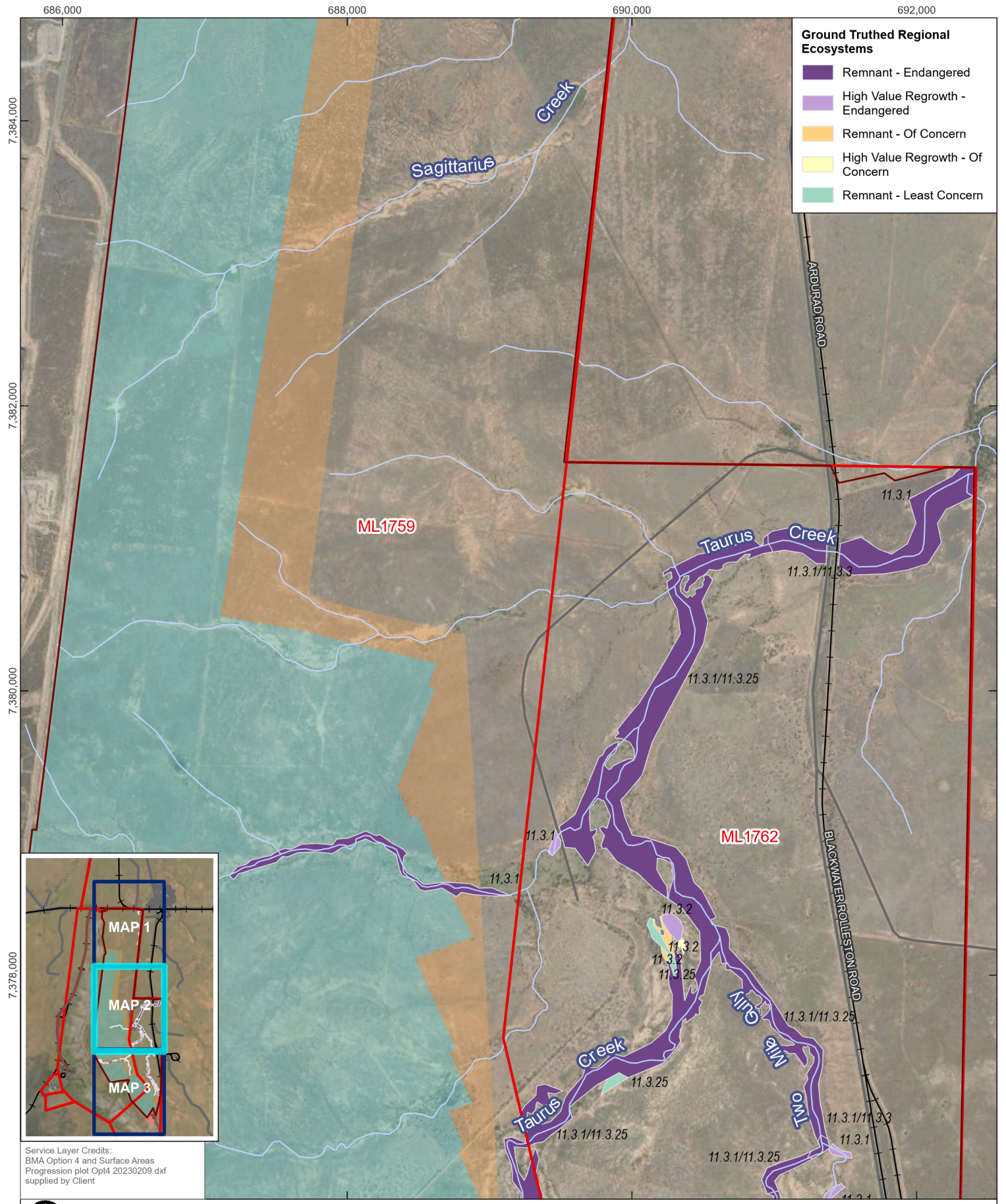

MAP 1 OF 3**

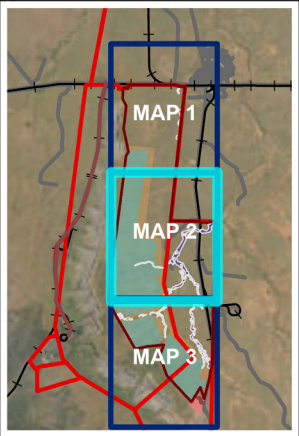

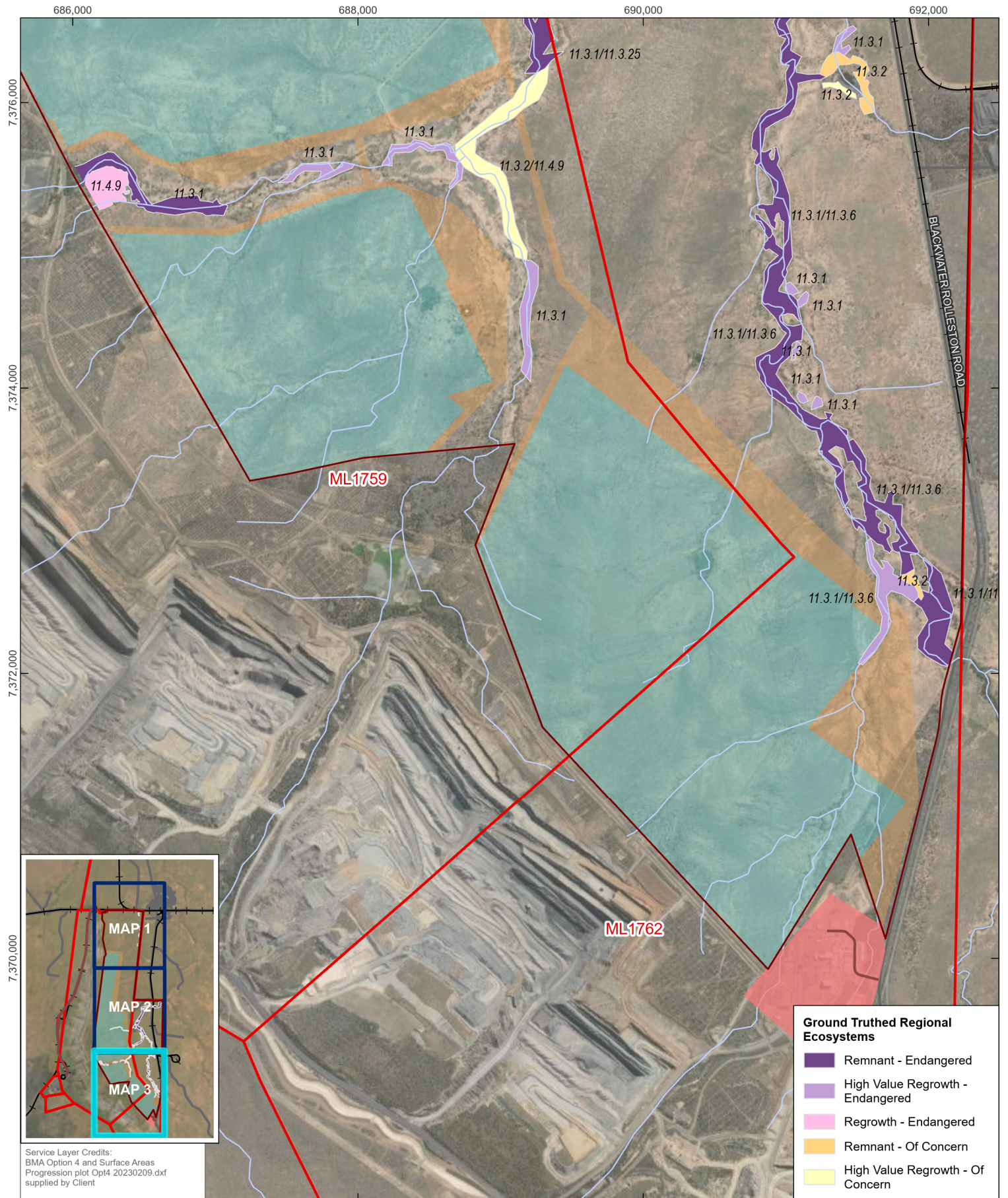
